#### ANNEXATION AGREEMENT

This Annexation Agreement is entered into this \_\_\_\_\_\_ day of \_\_\_\_\_\_, 2009, by and between THE BOARD OF TRUSTEES OF SHARON TOWNSHIP, a duly established and operating township under the laws of the State of Ohio (hereinafter "Township"), and THE CITY OF WESTERVILLE, an Ohio municipal corporation (hereinafter "City").

WHEREAS, to the extent consistent with the wishes of a Township landowner, the Township and the City wish to cooperate in facilitating annexation of certain territory of the Township to the City while also ensuring that the removal of such territory from the Township does not adversely affect the revenues of the Township; and

WHEREAS, such territory is set forth on the map attached hereto as Exhibit A and incorporated herein by reference; and

WHEREAS, this Agreement shall serve as an annexation agreement for purposes of Section 709.192 of the Ohio Revised Code;

NOW, THEREFORE, in consideration of one dollar and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the parties hereto, the Township and the City hereby agree as follows:

Section 1. If the landowner of land within the territory set forth on the map attached as Exhibit A petitions for annexation to City, the Township hereby consents to annexation of such area. The Township and the City agree to cooperate fully and in good faith with each other to achieve successful annexation of such lands within the subject territory.

Section 2. The Township and the City acknowledge and agree that this Agreement is intended to and shall serve as an annexation agreement pursuant to O.R.C. §709.022.

Section 3. The Township and the City acknowledge and agree that the City will undertake the necessary process to change the Township's boundaries under the procedures

described in Chapter 503 of the Revised Code to exclude the subject territory described in the map attached as Exhibit A from the Township.

Section 4. The parties acknowledge that the landowner of the territory to be annexed paid real property taxes to the Township in the amount of \$914.27 for tax year 2008. Pursuant to Section 724.192 of the Ohio Revised Code, the City and the Township agree that, as an alternative to the statutory reparation payments described in Section 709.19 of the Ohio Revised Code, the City shall make annual payments in the amount of \$457.19 to the Township as compensation for lost property tax. Such annual payments shall be made for a period of six (6) years, commencing in 2010. The annual payments shall be made on or before April 1 of each year (2010-2015).
