

AN ORDINANCE TO PETITION THE COUNTY COMMISSIONERS OF FRANKLIN COUNTY, OHIO FOR ANNEXATION OF APPROXIMATELY 31.049 ACRES OF LAND, LOCATED ON HOUCHARD ROAD, TO THE CITY OF DUBLIN
