

AN ORDINANCE TO PETITION THE COUNTY COMMISSIONERS OF FRANKLIN COUNTY, OHIO FOR ANNEXATION OF APPROXIMATELY 2.232 ACRES OF LAND, LOCATED ON COSGRAY ROAD, TO THE CITY OF DUBLIN

Section 3. The City Manager is hereby authorized to take any action necessary to effect the annexation petition.

Section 4. This Ordinance shall be in full force and effect on the earliest date permitted by law.
